2024 was another successful year for Carringbush, as we continue delivering programs to meet the needs of our community.

It was fantastic to have the value of our work recognised, with Carringbush announced as a finalist in three awards categories:

- 2024 Finalist Community Training Provider of the Year - Victorian Training Awards
- 2024 Finalist Partnership category
- Learn Local ACFE Awards
- 2024 Finalist Supporting Parents to Build their Capacity and Confidence -Victorian Early Years Awards

A significant highlight has been the establishment of a new Carringbush front-of-house, in the heart of the community at 108 Elizabeth St Richmond, after an extensive search. Our thanks to the team at Department of Families, Fairness and Housing for advocating for Carringbush to be the lead organisation in this important pilot to activate an unused community space. We know that being centrally located will allow Carringbush to more easily reach more residents.

The Board and Management come together twice a year to focus on and track our strategy. A process to strengthen our plans commenced in late 2024 to ensure we deliver impact for the community into the future. This work continues into 2025 and will culminate in an updated strategic plan that guides us as an organisation.

I would like to thank all the members of the Carringbush Board for their contribution to the important work of governance and for their commitment to continuous improvement. A special thanks to Maria Gindidis, who has stepped away from the board, after being a valued member for three years.

The Carringbush team continues to work together and with our valued partners to positively impact the lives of our students and program participants. On behalf of the Carringbush Board I would like to thank our CEO Margaret Corrigan and all the Carringbush team for their commitment to improving outcomes for the people in our programs.

### CEO's Report

#### 2024 has been another productive year for Carringbush!

Through the AMEP Connect Program, we were really pleased to be able to support seven Adult Migrant English Program students with individual, intensive pathways support, in partnership with several Learn Local organisations and the DHA AMEP Innovative Projects fund.

In collaboration with the Practera Industry Engagement Team, we were able to work with a number of students from the University of Melbourne to leverage off their creativity in Sustainability and Digital Challenges. Their innovative ideas on how we can better promote Carringbush programs provided a great platform for some new marketing approaches and design work, which we have been rolling out during the year. Thanks to Adam Fletcher from Dinosaurus Media Solutions for giving us a fresh new look!

Carringbush is known for our strong focus on building the capacity of teachers particularly in the areas of digital skill-building and the incorporation of pronunciation into the teaching of all English language skill areas. In recognition of the particular expertise of Carringbush Professional Learning Coordinator and teacher, Elizabeth Keenan, Melbourne Polytechnic invited Carringbush to deliver four workshops to 20 teachers across a number of Learn Local organisations and TAFE. The feedback received was fantastic.

The demand for our wrap-around support for individuals has been high this year, with increasing numbers of people finding it tough to make ends meet. We were very grateful for those who contributed to the Carringbush Winter Appeal, with funds raised allowing us to provide much-needed support with food vouchers.

An enormous thank you to our fantastic volunteers, who continue to make such a valuable contribution to the work of Carringbush. Across a range of areas, including individual mentoring; conversation groups; digital mentoring; classroom support and board member duties, 28 volunteers have donated 1190 hours of their time in 2024. We can't thank them enough! Special thanks to our new Volunteer Coordinator, Mary Dearing, who has done a wonderful job this year.

Thanks to the Board members for their commitment, with special acknowledgement of Ari Cassarchis who is stepping down after three years as Chair. He has brought considerable experience to the role and has spear-headed several improvements to the governance of Carringbush. Thanks Ari.

## Education **Program**

The Education Program at Carringbush in 2024 increased student enrolments by 10% and maintained its consistent funding sources of AMEP, Skills First and ACFE.

Our accredited program held 6 classes across the five curriculum levels. These classes were well attended with an average of 18 people in each class.

Our pre accredited classes were varied and we partnered with many different organisations to deliver classes to meet a specific need in our community.

Teachers worked hard to keep classes engaged and undertook a lot of professional learning, improving the way they taught digital and oral language skills.

We improved our PL offerings for staff, continuing to offer paid mentoring for digital and pedagogical skills. We also tightened up on the compliance and demonstration of staff PL.

Over both programs, we delivered strong digital literacy access and mentoring for students across many classes. This begins at the induction stages and carries over to in class mentoring and then out of class mentoring can also be arranged.

This digital focus at Carringbush has been a point for difference in our operations. We have a large digital lending library where we loan students iPads, laptops and internet dongles.

In term 4 our move to the Richmond Housing Estate at 108 Elizabeth St, for most of our classes and main offices has been a fabulous shift in delivery. This move enhances the community nature of our classes and underscores our mission.



#### **Highlights**

- Successfully completing our 5 year audit from VRQA with no rectifications required.
- Moving our main office and most of our classes onto the Richmond Housing Estate.
- 100% success rate on 2 verifications from AMEP audits.
- Successfully recruited an experienced EAL teacher who also became our digital capacity coordinator and has made a great start to the role, adding value to many aspects of the organisation.
- Teachers continued to grow their digital PL capabilities through mentoring and peer observations, enhancing students digital skills.




#### Special projects

- Liz Keenan and researcher Beth Zelinski began a research project to look at the value of using the phonemic chart as a tool to improve pronunciation with beginner level learners.
- This will carry over in 2025.
- Completing the partnership research project with ACU - investigating and building the digital capacities of our staff and students.
- Research project from Theresa Wall of Wollongong University: Leveraging the Home Languages of Adult L2 Learners with Emergent Literacy: Pedagogical Translanguaging as a Gateway to Metalinguistic Awareness at Carringbush Adult Education.

## Community Development

The Community Development team had an exciting year in 2024 with new partnerships, new programs and strengthening of existing programs.



#### **Key numbers**

- 36 women graduated from the Yarra Women Behind the Wheel program.
- 100 women participated in the African Women's Group.
- 15 families attended weekly family literacy programs.
- 60 participants supported with water safety and CPR, in partnership with Life Saving Victoria.
- 20 participants benefited from capacity building for hospitality employment, in partnership with Free to Feed.
- 100 participants supported with understanding MyGov and scams, over 5 sessions with Services Australia.



#### Yarra Women Behind the Wheel

We delivered three rounds of education for women drivers who are moving from their Learners license to Probationary license.

Delivered in partnership with MiCare, Victoria Police, Victoria Legal Aid, Neighbourhood Justice Centre, and the Financial Counselling team, the program provides holistic support with child-minding and interpreters available for participating mothers. Natalie Hutchins, Minister for Women and SBS World News visited the program.





#### **Targeted Employment Project**

Carringbush partnered with the Department of Families, Fairness, and Housing alongside Work Force Australia to deliver the Targeted Employment Project. This was an informal drop-in program t o support residents seeking employment support.





#### **African Women's Group**

Carringbush continued the role of lead organisation, in collaboration with MiCare and City of Yarra, to support 100 women each month. We covered topics requested by the women such as wellbeing, parenting, financial literacy, women's health and Centrelink services, as well as excursions to Fitzroy Gardens and the Melbourne Zoo.





#### **Hospitality Partnership**

Carringbush continued our partnership with Free to Feed to deliver a pre-employment program supporting people wanting to pursue a vocational pathway in the hospitality industry. Carringbush partnered to deliver two bespoke 8-week programs focusing on food safety and employability skills.



#### **Digital Literacy Partnership**

Carringbush continued to partner with the Social Studio to deliver short skill-building sessions on Digital Literacy and interview skills.



#### **Water Safety and CPR Training**

A wonderful day focusing on water safety was had by students at Port Melbourne Beach Club, with Life Saving Victoria, who also delivered CPR training and the Meet a Lifeguard program to Carringbush classes.







The Reconnect Program delivered individual training and employment pathways support with wrap-around casework for participants with barriers to participation and/or complex support needs. Carringbush delivered the program in partnership with Carlton Neighbourhood Learning Centre in an outreach model at a range of community venues across Richmond, Collingwood and Carlton. The majority of 2024 participants will continue their 18 months support working towards outcomes in 2025.

The Referral and Support Service (RASS) supported community members with form filling, short-term casework, digital access and referrals to local support services in Richmond and Collingwood. This service was supported and enhanced by Bicultural support staff Hoa Tran, Hanah Suleiman and Marjan Nikneshan .




#### Highlights

Outcomes for participants including enrolling in education and training, gaining employment and engaging in volunteering increased confidence and capacity to engage in community activities, engagement in education and employment; increased access to and engagement with support services; increased health and wellbeing; reduced financial hardship and the development of new relationships and social connections.



#### **Key numbers**

- 67 participants supported through Reconnect.
- 25 community members were supported through Richmond RASS, including 16 participants receiving employment pathways mentoring
- 43 CALD women were supported through face-to-face case management in the NJC Women's RASS program in Collingwood









#### **Identified Lived Experience of Participants:**

• People identifying as having a disability: 24%

■ People identifying as having a mental health condition: 55%

Disclosed experience of family violence: 27%

• People involved in the criminal justice system: 32%

Disclosed substance abuse disorder: 31%

■ People identifying as CALD: 66%



#### RASS outcomes across Richmond and Collingwood included:

- Practical and timely support to resolve immediate tasks such as form filling, digital access and communicating with services.
- Supported, culturally appropriate, timely and responsive referrals made to external organisations.
- An increase in participants' access and participation in local services and an increased reach of local services.
- Direct Financial Hardship Support in the form of Coles Vouchers, food aid and Myki fares was provided to over 50 people experiencing homelessness, family violence and/or extreme financial hardship.



#### Special projects

- The Pathways to Success project delivered individual career pathways guidance and ongoign mentoring to 16 CALD adults in Richmond. Outcomes identified included increased understanding of employment opportunities and the job market in Victoria, increased confidence and capacity for job seeking, increased skills and knowledge for seeking employment, increased vocational and employability skills, increased language, literacy and digital skills for employment, engagement in further training, increased networks for employment.
- Carringbush participated in a pilot Citizenship Clinic in partnership with the Neighbourhood Justice Centre and Fizroy Legal Service, with the legal team coordinated by Fitzroy Legal Service. At December 2024, the Pilot had assisted 11 clients. 2025 plans include securing additional fuinding to expand the program and to deliver Community Legal Education session.



#### NOTE 1 - STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report that has been prepared in accordance with the Australian Accounting Standards, other authoritative pronouncements of the Australian Accounting Standards Board and the requirements of the Associations Incorporations Act (Victoria).

The financial report covers Carringbush Adult Education Inc. an individual entity. Carringbush Adult Education inc. is an association incorporated in Victoria under the Associations Incorporation Reform Act 2012.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted by Carringbush Adult Education Inc. in the preparation or the financial report. The accounting policies have been consistently applied, unless otherwise stated.

#### **Income Taxes**

Carringbush Adult Education Inc. is a Charitable Institution and is Income Tax Exempt.

#### Property, Plant & Equipment

Each Class of Plant & Equipment is carried at cost or fair value less, where applicable, any accumulated depreciation.

The carrying amount of plant & equipment is reviewed annually by the Committee to ensure it is not in excess of the recoverable amount of those assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets' emoloyment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

The depreciable amount of all fixed assets are depreciated on a straight line basis over the useful lives of the assets to the Committee commencing from the time the asset is held ready for use.

The Depreciation rates used for each class of depreciable asset are:
